  - 5.1 Follow-up from last month's meeting: Kindergarten and Split Grades

Kindergarten numbers next year are at 23 students. This year the kindergarten classroom is at 21 students with an EA. Next year's kindergarten class at current numbers will need to be split and the school needs more space available to accommodate a larger kindergarten class.
